Recognizing that certain groups of people require interventions to meet unique needs, the Center offers culturally and age appropriate services.

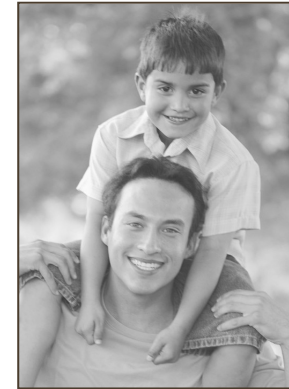
